Existential Threats to Practices: Revocations, Suspensions & Extrapolations

CLE | CME

CMS regularly takes actions against physician practices which can bankrupt them. For most physician groups, the biggest threats to their survival are not Stark, Anti- Kickback or Civil Monetary Penalties liability. Rather, revoking billing privileges can prohibit a practice from billing Medicare, Medicaid, or commercial payors for 10 years or more. CMS's program integrity contractors commonly and increasingly impose suspensions without prior notice. Extrapolations of overpayments can also severely damage or ruin a practice. Reclaiming Physician Wellness: Burnout and Solutions in Law and Practice

Over 50% of doctors report burnout. The pandemic, workplace violence, provider shortages, and administrative burdens are compounding factors. When clinicians are afraid to seek the care they need, they may be unable to work due to depression, or burnout. Some abuse substances; some leave medicine. The stigma associated with seeking or even discussing behavioral healthcare is a primary driver of suicide.
