Clients appreciate our ability to solve multijurisdictional challenges a result of our collaborative culture:

- **In 2019, 16 out of 20 of the firm's largest clients used lawyers in 10 or more of our offices.** For the firm's 100 largest clients, which generated 33.2% of revenue, the average number of offices engaged was 12.
