## Graduate Program

The program runs for 12 months, in which time you will complete three practice group rotations. You will be exposed to a variety of areas of corporate law in all your rotations.

Throughout the year you are supported by a buddy, supervisor and mentor. Partners and senior lawyers will support and guide you through each rotation and ensure you get the necessary development. Your buddy—a junior lawyer—will help you transition into your new role.

Your professional development program runs weekly. It combines Practical Legal Training (delivered in-house by the College of Law), with sessions presented by partners, lawyers, external presenters and our professional development team.

You will have many opportunities to be involved in an array of firm events and activities to match your interests, whether they be social, sporting, business or community-focused.

## The Application

## The Interview Process

You will experience a two stage interview process with us.

### First Round Interview

Your first interview will be with one of our senior lawyers that are part of our recruitment team, as well as a member of our Human Resources team.

We accept clerkship and graduate applications in line with law society guidelines in the relevant state. Please visit [klgates.com/careers](http://klgates.com/careers) for application dates by office location.

The first interview is our opportunity to get to know you and will expand on your application, your interest in K&L Gates and will be a chance for you to get to know us.

### Second Round Interview

For Melbourne and Sydney applicants, the second interview is a group activity. You will work through a series of legal scenarios with a group of candidates and two members from our recruitment team.

The group interview is aimed at assessing your ability to demonstrate your analytical skills and to think critically and commercially as well as your teamwork skills (an essential skill for our lawyers!).

As part of our second interview, we host an information session, giving you another opportunity to meet our people and get to know more about life at K&L Gates.

For Brisbane and Perth applicants, you will either have a group activity or have a second round interview with a partner and special counsel or senior associate. This will take a similar format to your first interview but is another opportunity for you to meet people in different teams and to get to know the firm—so be sure to ask the questions you really want the answers to.

# TIPS FOR SUCCESS



## Application Tips

Your online application is your first opportunity to stand out. Take a look at the key attributes we look for in a clerk or graduate and tailor your application to showcase these.

If you don't have legal experience, don't make this a focus of your application. Instead, tell us how the experiences you have had would relate to a clerkship or graduate position at our firm. Remember, you gain and build on key skills through all aspects of your life, so be sure to include relevant work history, academic achievements and personal interests—these all make you!

Wondering how to demonstrate your commerciality? Remember, we are a corporate law firm, so tell us about your interests in commercial aspects of the world, such as in business or finance. Explain why you want to be a corporate lawyer and why are you interested in K&L Gates specifically. We understand you will be applying to other firms but make sure you tailor your application to show us why K&L Gates is the right place for you to start your legal career. Take a look at our website to find out who we are but don't just copy and paste from there—we know who we are, we want to know who YOU are.

Before you submit your application, read it again, then again. Then, ask someone else to read it! Accuracy and attention to detail are key skills for a lawyer and you need to demonstrate this in your application. So make sure you correct any typos—or references to other firms!



## Interview Tips

First impressions really do count, so make sure you consider this when preparing for your interview. Double check the date, time and location of your interview and plan ahead—know where our offices are so you are on time. Not only is it a bad look to be late, you will feel far more relaxed and comfortable if you arrive in good time and are able to sit and gather your thoughts for a few minutes before your interview.

Know your CV and application form back to front. This forms the basis of our interview and we will ask you questions in relation to the information you submitted.

Most importantly be yourself. Be honest in your responses and don't be afraid to ask questions about us or the firm that are specific to what you are looking for in an employer.
