Externally, we support the global LGBTQ+ community through pro bono work and community involvement. For example, we partner with the Transgender Legal Defense & Education Fund to participate in their Name Change Project in numerous jurisdictions around the country. Additionally, in conjunction with law enforcement in Western Pennsylvania, our firm founded the Anti-Human Trafficking Initiative to identify members of the LGBTQ+ community who may be victims of human trafficking and help connect victims to law enforcement.

We also partner with many local, national, and international organizations focusing on LGBTQ+ inclusion, including Lambda Legal, QLaw, the Albert Kennedy Trust, Kaleidoscope, the National LGBTQ+ Bar Association, Pride in Diversity in Australia, and Switchboard LGBT+ Helpline in the United Kingdom. Furthermore, we present, network, and recruit at the National LGBTQ+ Bar Association's Lavender Law Conference & Career Fair, the largest LGBTQ+ legal conference in the country, each year.
